

About Amendment of the Child Allowance Law in 2022

1 As a general rule, there is no longer a need to submit a Current Status Report (Genkyo Todoke).

⇒ The notification of Current Status Report (Genkyo Todoke), which used to be submitted every June, will no longer need to be submitted.

※ For those who are eligible for (1) 「A」 below, it is necessary to continue submitting the Current Status Report (Genkyo Todoke).

※ For those who have not yet submitted the Current Status Report (Genkyo Todoke) for the fiscal year 2021 or earlier, it is necessary to submit the report for the fiscal year that has not yet been submitted.

2 The upper income limit for the payment of special benefits will be established.

⇒ Depending on the amount of income, there will be some people who will not receive the special benefits.

◎ Details of the changes above.

(1) About omission of Current Status Report

A Starting with the 2022 Current Status Report (Genkyo Todoke), the current status of Recipient will be confirmed by public records, etc, making the submission of the Current Status Report unnecessary in principle. However, the following persons must continue to submit the Current Status Report (Genkyo Todoke). For those Recipient who are required to submit a Current Status Report (Genkyo Todoke), we will send you a form to fill in around the beginning of June. Please submit this form.

- ① Those whose address on their resident card is different from Isesaki City due to spousal violence, etc.
- ② Those who do not have the family register or resident card of the child for whom the payment is required.
- ③ Those who are separated from their spouse during divorce proceedings.
- ④ Recipients that are legal entities like guardianship of minors, institutions, etc. (including foster parents)
- ⑤ Others, who have been guided to submit by Isesaki City

※ We may contact you if the requirements for payment cannot be confirmed in the public register.

※ Depending on your income and other factors, you may be asked to change your Recipient.

B The following changes are also required to be reported.

- ① When the address of the spouse who lives in a city other than Isesaki City has changed
- ② When the recipient's pension plan changes from 「National Pension Plan to an Employees' Pension Plan」 or 「Employees' Pension Plan to National Pension Plan」.
※ This is not required if there are no children under the age of three eligible for benefits.
- ③ When a recipient who is in the middle of a divorce agreement gets divorced.

(2) About Income Limits ・ Maximum Income Limit

From October 2022, if the income of the person who is taking care of the child is equal to or more than ② in the following table, the child allowance will not be paid. A notice of expiration of eligibility will be sent to recipients whose eligibility for benefits has been expired.

※ Please note that if your income decreases under the ② after you are no longer receiving the child allowance, **you will need to submit a new application form.** Applications must be made **within 15 days** of the day following the day on which you have receive your Citizen's Tax Notice. Please note that if you delay the procedure, you will not receive the allowance for the delayed month.

- ・The number of dependents is the number of dependents according to tax law.
- ・If the number of dependents exceeds 3, the amount of ¥380,000 will be added per person.
- ・The 「Income standard」 is calculated based on salary income only.

※If you apply late, in principle, you will not be able to receive the child allowance for the month of the delay.

Also, please note that if an overpayment occurs, you will be required to return the allowance.
